

Terms & Conditions

2026 AHA NSW People's Choice Competition

Information on how to enter and prizes form part of these terms and conditions.

Any entry not complying with these terms and conditions is invalid.

Eligibility for voters:

Entrants must be a resident of New South Wales (NSW) aged 18 and above.

Competition commences at 12:01am AEST on Monday 24 August 2026 and closes at 11:59pm AEST on Sunday 20 September 2026. All online entries received after this date will be ineligible. To be eligible to enter during the competition period, each entrant must complete the online entry form. Online entries must be submitted via www.ahaawardsnsw.com.au/peoples-choice providing the nominated NSW based venue name and suburb.

Only one (1) entry allowed per entrant during the competition period except for the second round of voting when one (1) per day per entrant is allowed.

Prizes:

There will be four (4) opportunities for "Entrants" to win a \$250 Gift Card. Winners will be randomly drawn from all eligible entries received to win one (1) Gift Card valued at the maximum retail value of \$250 to be used for food and beverages at the "Entrant" winner's favourite AHA NSW member pub.

Eligibility for venues to be considered for the AHA NSW People's Choice Award:

Any pub who is a current member of AHA NSW is eligible to win this award. Competition commences at 12:01am AEST on Monday 24 August 2026 and closes at 11:59pm AEST on Sunday 20 September 2026. Finalists will be determined based on the total of all collated online entries received. The People's Choice Award finalists will be announced on Friday, 25 September 2026.

An extended voting period for finalists will commence at 12:01am AEST on Monday 5 October 2026 and will close at 11:59pm AEST on Sunday 18 October 2026. The People's Choice Award

winning pub will be declared the winner based on the total of all collated online entries received at the conclusion of the competition.

One (1) entry **per entrant per day** is allowed during the second round of voting.

Prize:

During the extended voting period, there will be one (1) opportunity for "Entrants" to win a \$500 Gift Card. The winner will be randomly drawn from all eligible entries received to win one (1) Gift Card valued at the maximum retail value of \$500 to be used for food and beverages at the "Entrant" winner's favourite AHA NSW member pub.

The entrant winner of the \$500 Gift Cards will be notified via email (as supplied on the entry form). The entrant winner will receive a digital \$500 Gift Card via the email address provided on entry so it can be used straight away.
